Stony Brook UG Biology Scholarships

Michel Colbert Endowed Scholarship: The goal of this scholarship award is to enhance successful completion of degree, preferably in the biological sciences, for a student confronted with significant and unanticipated financial difficulties. Although there is no strict requirement for the year of study, students are typically selected as Michel Colbert Fellows prior to their senior year and receive a full tuition scholarship to support their studies through graduation as long as they maintain good academic standing and full-time status.

Deadline March 21, 2018

Edward J. Mardovich '81 Memorial Scholarship: The scholarship is available to any U.S. citizen Junior or Senior Biology major, with a GPA greater than 3.0. Selection will be based on both the academic record and a personal statement that addresses the importance of their studies to their long-term career plans and how receipt of the scholarship support will enhance these plans. Awards to cover \$1,000 of educational expenses per semester will be given for a full academic year, with a possibility of renewal for students who receive the Scholarship as a Junior. Recipients will be expected to maintain continuous full-time enrollment with a minimum GPA of 3.0 for the entire scholarship period.

Michel Colbert Scholarship Application

The Michel Colbert Endowed Scholarship was established to honor the memory of Michel Colbert, a Biology graduate from the class of 1986 who was killed in the September 11, 2001 attack on the World Trade Center. The goal of this scholarship award is to enhance successful completion of the Bachelor of Science in Biology for a student confronted with significant and unanticipated financial difficulties. Although there is no strict requirement for the year of study, students are typically selected as Michel Colbert Fellows prior to their senior year and receive a full tuition scholarship to support their studies through graduation as long as they maintain good academic standing and full-time status.

The criteria for selection of a Michel Colbert Fellow are:

- A Stony Brook undergraduate with a strong record of achievement, preferably in the biological sciences with a clear plan for completion of a Bachelor's degree program.
- Unanticipated financial challenges that are likely to interfere with timely completion of the undergraduate degree program at Stony Brook.
- A personal statement to be shared with the Colbert family that explains your course of study and how this education will impact on your career development and future plans.

The Edward J. Mardovich '81 Memorial Scholarship in Undergraduate Biology was established by family, friends and fellow alumni of Eddie to provide a permanent source of scholarship support to Stony Brook undergraduate students majoring in Biology. Eddie earned degrees at Stony Brook in Biology and Sociology. He was a former employee at Euro-Brokers, Inc. and was tragically killed in the terrorist attack on the World Trade Center on September 11, 2001. The scholarship is available to any Junior or Senior majoring in Biology with a GPA greater than 3.0. The scholarship is restricted to United States citizens. Selection will be based on both the academic record and a personal statement that addresses the importance of their studies to their long-term career plans and how receipt of the scholarship support will enhance these plans. Awards to cover \$1,000 of educational expenses per semester will be given for a full academic year, with a possibility of renewal for students who receive the Scholarship as a Junior. Recipients will be expected to maintain continuous full-time enrollment with a minimum GPA of 3.0 for the entire scholarship period.

The criteria for selection of an Edward J. Mardovich '81 Scholarship are:

- A Biology major who is a United States citizen and who will have Junior or Senior status during the Scholarship period with a minimum GPA of 3.0.
- A personal statement to be shared with the donors that addresses the importance of your studies and extracurricular experiences to your long-term career plans and how receipt of this scholarship award will enhance your career development.

GUIDELINES DIVERSITY ABROAD HONORS SCHOLARSHIP PROGRAM (DAHSP) AY 2017-18

Introduction

SUNY's Office of Diversity, Equity and Inclusion (ODEI) is again offering its undergraduate scholarship program to diverse students interested in participating in one of SUNY's many study abroad programs. The Diversity Abroad Honors Scholarship Program (DAHSP) recognizes the valuable benefit that SUNY's international education programs provide. We encourage campuses to nominate students who might not otherwise be able to study abroad for the Diversity Abroad Honors Scholarship Program through their Study Abroad Program Office or coordinator. Through this program, ODEI hopes to offset the costs of participating in an approved credit-bearing overseas academic program. DAHSP supports ODEI's mission in striving to promote inclusive educational programs that reward academic excellence and those that expand students' knowledge of diverse peoples throughout the world.

The Diversity Abroad Honors Scholarship Program complements an existing statewide undergraduate scholarship program for students from a broad range of backgrounds who will contribute to the diversity of the student body in their campus or academic program. A limited number of scholarships of up to \$1,000 each will be awarded to students who satisfy the eligibility criteria. Campuses must also identify a source of matching funds equal to or greater than the scholarship award for a total grant up to \$2,000. Funds may be used to support a variety of international experiences, including, but not limited to:

- Global research experiences or internships;
- Short-term or semester studies, including summer and/or J-term programs;
- Mentorship/study/research in STEM disciplines;
- Credit-bearing summer study programs including cultural immersion;
- Faculty-led programs, including those embedded in academic courses.

Program Administration Guidelines

- A. Campus Participation: Only students nominated by the Study Abroad Program Office from state-operated campuses and community colleges are eligible for consideration under this program. On campuses that have no designated Study Abroad Office, nominations can come from the Vice President for Academic Affairs.
- B. Program Funding: ODEI-funded support will not exceed \$1,000 per student. Campuses matching funds must equal or exceed the state-funded ODEI allocation. Federal financial aid funds (Title IV) cannot be used as matching funds.
- C. Student Eligibility: Each campus is responsible for establishing a procedure to nominate award applicants. This process must include promotion of the scholarship opportunity (announcements, flyers, web postings, distribution lists) and additional evaluation by the campus to determine eligibility. The following requirements and guidelines should assist campuses in the selection process:

Academic Criteria:

- Students will be enrolled in a degree program with a declared major at a sponsoring SUNY campus;
- Rising sophomores, juniors and seniors are eligible to compete for study/travel awards;
- Transfer students will become eligible to study abroad during the second semester of enrollment in a SUNY two-year or baccalaureate program;
- Each campus will define the criteria for high achievement and minimum GPA for scholarship nomination; recipients may be enrolled in less than full-time status, providing they continue to meet campus definition of high achievement.

Financial Criteria:

- Candidates are not required to demonstrate financial need. Financial aid and loans may be used to support tuition and additional costs of study abroad programs. Completion of a FAFSA for Pell, TAP and family-based resources may be required by the Study Abroad Program Office at your college.

Additional Eligibility Criteria:

- Candidates must be United States citizens, permanent resident aliens and New York State residents. Those nominated from underrepresented and low-income categories may receive positive consideration as diversity candidates. Campuses may consider financial need and economic disadvantage as a **diversity indicator**, but applicants must also meet a high academic standard as evidenced by GPA and supporting recommendations.

D. Allocation of Scholarship Funds to Campuses:

Diversity Abroad Honors Scholarships will be awarded on the basis of merit-based campus nominations. Nominations will be coordinated and submitted by the respective campus Study Abroad Program Office or where no study abroad office exists, the Vice President for Academic Affairs.

The completed application packet should only be returned by the Office of International Studies or Study Abroad Program Coordinator or the Vice President for Academic Affairs.

Please submit the completed application packet electronically to Barbara.Hardman@suny.edu. The deadline for receipt of proposals is October 6, 2017 by 5 p.m. (for study in winter or spring 2018) and March 9, 2018 by 5 p.m. (for study in summer or fall 2018).

Funding for this initiative is limited and will begin with the 2017-18 academic year. Campuses may nominate only **one** candidate per semester. There will be two rounds of nominations during the 2017-18 academic year.

Application Completion and Nomination Requirements

- A. Candidates should complete the application process with the approval of the Study Abroad Program Officer. A complete application packet will include:
 - A completed application form, signed and submitted to ODEI by the Study Abroad Program Officer or Coordinator;
 - A personal essay (1-2 pages) outlining what the candidate hopes to achieve through study abroad, such as cultural/language immersion, research, mentorship, travel, etc.;
 - One recommendation (i.e.: Department Chair, Faculty Advisor, Program or Research Coordinator).
- B. Post-travel Experience:
 - **Program Report:** Students receiving awards will be required to submit a summary of their experience detailing how it contributed to their career and college goals within 60 days of completing their travel to the Office of Diversity, Equity and Inclusion.
 - **Program Ambassador:** Students must be willing to share their travel experience in a college or conference forum following their study abroad experience, including the submission of a high-resolution facial photograph for promotional purposes.

Other Important Information Regarding Prerequisites Requirements

- Applicants are required to complete the above prerequisite course(s) with a grade of C or better prior to matriculation. In addition, a minimum cumulative math/science GPA of 2.5 (on a 4 point scale) is required, although a GPA of 3.0 or above is preferred.
- A Bachelor of Science degree (or a BA) is preferred, but not required
- The PCAT is mandatory; no minimum score is required
- All prerequisites must be completed by the end of the Spring prior to matriculation. Students taking more than 2 courses in the summer prior to matriculation must receive prior approval from the SPPS Office of Academic and Student Affairs.
- In accordance with SUNY policy students must complete the general education requirements as defined by the Stony Brook Curriculum, commonly referred to as SBC. Candidates who have not met the SB general education requirements at the time of application, will be required to meet them by the matriculation date. Please consult your advisor or visit: http://sb.cc.stonybrook.edu/bulletin/current/policiesandregulations/degree_requirements/stonybrookcurriculum.php for details.
- All prerequisites must be completed within seven (7) years prior to matriculation.
- An in-person interview is required for applicants so skills not reflected in the application can be evaluated. Such skills include the ability to think clearly and logically, self-confidence, ability to work with a group and verbal and written expression of ideas.
- Students need to be aware of the additional prerequisite requirements beyond academic coursework that may be considered in the holistic review of each applicant including (but not limited to): letters of recommendation, community service, extracurricular activities, work experience and leadership.
- All applicants must meet the [Technical Standards for Admission, Progression and Graduation](#) and once accepted submit to a [Drug Screen](#) and [Criminal Background](#) check.
