2012 BENJAMIN AND DAVID SCHARPS LEGAL ESSAY COMPETITION

Description

The award is offered in accordance with a gift accepted by the State University of New York Board of Trustees under the will of Hannah S. Hirschhorn to establish the Benjamin Scharps and David Scharps Memorial Fund. Students will be asked to write an essay on a legal topic and submit their paper for review. A selection committee will review all submissions and select both a first and second place winner. This award is offered annually.

Eligibility

Competition for the prize is open to SUNY students in their junior and senior year at state-operated campuses. Students, who are interested in legal issues, or interested in pursuing a career in the legal field, are especially encouraged to apply.

Each participating SUNY campus may submit a maximum of three essays. Each campus president appoints a single faculty or staff coordinator, who must endorse each essay submitted, indicating that he or she has read the essay and considers it of high quality and represents the best of that campus.

Prizes

The winner will receive \$1,500; the second place finisher will receive \$1,000. Both the first and second place winners will receive a certificate and will be added to the recipients list on the SUNY website.

Instructions

The competition requires students to demonstrate their analytical skills in a legal opinion of 2,000 words. Students are to identify the legal issues and defend a position in a scholarly manner. The essay submitted must be carefully reasoned, well researched, authoritatively documented, and precisely written. It is to be neatly printed on 8.5 x 11 paper, and may include notes or foot notes.

The selection committee has requested that the name of the student and the name of their campus not be included on any of the narrative pages. The application cover page will be redacted from each submission, allowing the committee to review the applications anonymously.

An application cover sheet must accompany each submission. A copy of the cover sheet is included in this packet. The essays must be submitted to System Administration by the campus faculty/staff coordinator.

Deadline

Submissions should be sent to: Dr. Edward Engelbride, Associate Provost, State University Plaza S504, 353 Broadway, Albany, New York 12246 and must be received on or before **February 24, 2012**.

Selection Procedures

The Associate Provost, in consultation with the Selection Committee, will recommend the winner and runner-up to the Chancellor for approval, and the results of the competition will be announced on or before **March 19, 2012**.

BENJAMIN AND DAVID SCHARPS LEGAL ESSAY COMPETITION

Case Topic: Cyber Bullying

The First Amendment to the United States Constitution states that, “Congress shall make no law...abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.” Relevant Supreme Court cases also apply this restriction to states, including the State University of New York.

At the same time, many a mother has told her child that, “sticks and stones may break your bones, but names will never hurt you.” Yet study after study, and plain experience, show that often not to be the case. While name calling and taunting have plagued playgrounds since time immemorial, the advent of the Internet has made it significantly easier to stalk, taunt, expose and harass others, all from the comfort of one’s home, and without ever confronting the victim or exposing the identity of the poster. Results range from hurt feelings to cutting to suicidal ideation and other self-harming behaviors.

For your essay, discuss whether there is a legal role or responsibility of SUNY Colleges in addressing cyber bullying. In your essay, you may wish to address some or all of the following issues: Does the First Amendment allow a College to regulate harassing speech, either on campus or on the Internet? Are there legal steps that a college must take, should take, should not take, *or* may not take in addressing cyber bullying? May *or* should a college block access to a Web site that contains offensive content? May *or* should a college discipline a harasser through the judicial or conduct process? What legal and administrative options exist for students who are harassed or defamed on the Web? What, if anything, is the College’s educational role in addressing cyber bullying?

Please cite to at least five (but likely more) sources which can include statutes, court cases, journal and periodical articles, Dear Colleague Letters issued by the Department of Education’s Office of Civil Rights, and stakeholder’s Web sites. Please be careful to cite to other’s work and only use other’s work to strengthen your own arguments and analysis, not as a replacement for your own thoughts.

To ensure anonymity, please refrain from including your name or the name of your home institution on any page within the essay. Please place this information on a cover page accompanying your essay. This page will be redacted during the selection process and essays will be reviewed anonymously.
