Mon, Apr. 6	Advance Registration: Tentatively to begin for Summer/ Fall 2020 in accordance to enrollment appointments .
Mon, May 11	Graduation Application Begins: Degree candidates can begin to apply for Fall 2020 graduation via SOLAR .
Mon, Apr. 20	Open Enrollment Graduate Courses: Graduate students (non-matriculated & matriculated) may begin to enroll in grad courses.
Fri, Aug. 21	Open Enrollment Undergraduate Courses: Graduate students (non-matriculated & matriculated) may begin to enroll in ugrd courses.
Sun, Aug. 23	Semester Cancellation: Last day students can cancel all classes by dropping via SOLAR .
Mon, Aug. 24	<ul style="list-style-type: none"> • Semester Start: First day of classes. • Senior Auditing Program (Age 60+): Registration and start of program
Fri, Aug. 28 4:00 PM	Waitlist: Last day to waitlist a class. Students are responsible for any tuition liability incurred if registered from a waitlisted class.
Mon, Aug. 31	• Late Registration: \$50 fee automatically billed (per session) if not enrolled in at least one class before August 30 th .
Thur., Sep. 3	Waitlist Process Ends: Last day to be enrolled from the waitlist process pending seat availability. Students must contact the appropriate academic department after this date.
Fri, Sep. 4 4:00 PM	<ul style="list-style-type: none"> • Late registration ends for Graduate/SPD Students (includes SPD Online Session): Last day to process enrollment changes (adds, swaps, credit changes, drops) via SOLAR. Last day to drop/withdraw from the university without a "W" (withdrawal) recorded on transcript via SOLAR. Changes must be processed by 4:00 PM. Petition to the respective college/school required after this date. • Ugrd. Students enrolling in Grad/SPD courses: Last day to petition to the Graduate School/SPD. • Senior Auditing Program (Age 60+): Online registration closes. Processing of registration begins.
Mon, Sep. 7	Labor Day observed: No classes in session.
Tue, Sep. 8- Mon, Sep. 14	Swaps by Petition Only: Graduate and SPD students must petition to the respective school.

Fri., Dec. 4	Graduation Application: Last day for Masters & Advanced Graduate Certificate students to apply for graduation via SOLAR . All other students should contact their respective college/school. Applications submitted after 11/11/20 will not appear in the Commencement Publication.
