#### I. General Information

On behalf of the Curriculum Committee, I am pleased to submit our annual report for the last academic year, 2012-2013. This report was discussed and approved by the Committee on September xx, 2013.

The report includes excerpts from the meeting minutes that discuss issues submitted to the Committee. As Chairs of the Curriculum Committee in AY 2012-2013, we would be happy to meet with the Executive Committee and/or the Senate to discuss the Committee's concerns.

The curriculum committee met 25 times during the 2012-2013 academic year (six of those 25 times were meetings of the Stony Brook course certification committee). Committee members were: Ritch Calvin (Women's and Gender Studies in the Department of Cultural Analysis and Theory and Chair of the committee for the Fall 2012 semester), Darcy Lonsdale (School of Marine and Atmospheric Sciences and Chair of the committee for the Spring 2013 semester), Beth Squire (College of Arts and Science Dean's Office, elected professional staff member), Ryan Minor (Music), Abhay Deshpande (Physics), Richard Gerrig (Psychology), Anne Moyer (Psychology), Peter Stephens (College of Arts and Sciences, ex officio member), Kane Gillespie (College of Arts and Sciences, Executive Secretary of the committee, ex officio member), Arlene Feldman (Center for Advising and Transfer Services, ex officio member), and Jessica Munno (Registrar's Office, ex officio member). Ridha Kamoua attended as an ex-officio representative from the College of Engineering and Applied Sciences.

Routine matters are handled by the secretary and announced to the committee at each meeting. There were a number of routine matters chiefly involving deletion of courses, reactivation of courses deactivated within the past five years, minor changes to major and minor Bulletin text, and changes of course titles, descriptions, course combinations and/or prerequisites to bring them in line with current teaching practices.

The Committee worked to publish two updated online versions of the 2013 Bulletin (Spring 2013 and Fall 2013 editions). The secretary also serves as the Editor of the Bulletin, and elected professional CAS Dean's Office staff member Beth Squire serves as Assistant Editor of the Bulletin.

#### II. General Curricular Matters

The committee approved forty-six new courses during the 2012-2013 AY, along with a new minor in Hellenic Studies. The committee also discussed two Registrar updates, post enrollment requisite checking and the permission to drop feature of PeopleSoft. The committee requested additional feedback from the three departments that tested post enrollment requisite checking, and asked that "Permission to drop" should not be available for courses within the purview of the Arts and Sciences Senate without written approval by the Arts and Sciences Undergraduate Curriculum Committee. While the functionality has the potential to help students in their progress towards degree completion, the committee would like to ensure that it does not create unnecessary red tape for students during a busy time of the semester.

The committee met six times during the Spring 2013 semester as part of the larger Stony Brook Curriculum Course Certification Committee. The SBCCC is made up of all of the members of the Curriculum Committee, along with members representing other academic and non-academic areas on campus. During the Spring 2013 semester, the SBCCC concluded Phase I of the implementation process, during which the committee approved Stony Brook curriculum categories for 1,145 existing D.E.C. courses, and discussed general questions of what type/level courses will fulfill the SBC categories. A smaller sub-committee of campus administrators familiar with the D.E.C. system met an additional four times to review and discuss the existing D.E.C. courses and the appropriate corresponding SBC category.

While the target for implementation remains Fall 2014, committee members questioned who will identify gaps in missing courses, and who will figure out if there are ample opportunities for students to meet the new requirements. Faculty members from the committee agreed that there is an existing model of how student seats are distributed, and departments are already making decisions predicated on how many seats the department needs to provide years down the line for the university. While the committee encourages a positive response to the new requirements, faculty voiced concern over the new requirements dictating a redistribution of seats for which departments are unprepared. A committee member suggested that before the changes to the general education are implemented, focus groups be conducted of current and prospective students to determine whether students find the new system easier to use and understand than the current DEC and other SUNY models. The committee member questioned whether the new model will be attractive to potential students, and supports the collection of data on impressions of the new system.

Two main concerns about the new curriculum include seat availability and accessibility (especially in the new "pursue deeper understanding" and other areas that are equivalent with areas of the DEC that have been problematic in recent years--DEC D, H, I, J and Skill 4), and consistency of SBC categories among subjects and departments.
