I. General Information

On behalf of the Curriculum Committee, I am pleased to submit our annual report for the last academic year, 2016-2017. This report was discussed and approved by the Committee on September 27, 2017.

The report includes excerpts from the meeting minutes that discuss issues submitted to the Committee. As Secretary of the Curriculum Committee in AY 2016-2017, I would be happy to meet with the Executive Committee and/or the Senate to discuss the Committee's concerns.

The curriculum committee met 18 times during the 2016-2017 academic year. Committee members were: Arlene Feldman (Academic and Transfer Advising Services, ex officio member), Kane Gillespie (College of Arts and Sciences, ex officio member), Dawn Harris (Africana Studies), Marie Huffman (Linguistics, committee co-Chair), Izabela Kalinowska Blackwood (Cultural Analysis and Theory), Roy Lacey (Chemistry), Sarah Malmquist (Neurobiology), Robin McCarthy (Registrar's Office, ex officio member), Greg Ruf (Asian and Asian American Studies, committee co-Chair), Deborah Serling (Academic and Transfer Advising Services, elected professional staff member), and Beth Squire (College of Arts and Science Dean's Office, Executive Secretary of the committee, ex officio member).

Routine matters are handled by the secretary and announced to the committee at each meeting. There were a number of routine matters chiefly involving deletion of courses, reactivation of courses deactivated within the past five years, minor changes to major and minor Bulletin text, and changes of course titles, descriptions, course combinations and/or prerequisites to bring them in line with current teaching practices.

The Committee worked to publish the updated online versions of the Fall 2017/Spring 2018 Bulletin. The executive secretary of the committee also serves as the Editor of the Bulletin.

II. General Curricular Matters

The committee approved 31 new courses during the 2016-2017 AY.

During the 2016-2017 academic year, the committee electronically submitted and approved courses for the larger Stony Brook Curriculum Course Certification Committee. Agenda items were sent to the SBCCC for approval in March, 2017. The SBCCC is made up of all of the membership of the Curriculum Committee, along with members representing other academic and non-academic areas on campus. The SBCCC voted on and approved courses pre-approved by the Arts and Sciences Senate Curriculum Committee, and the College of Engineering and Applied Sciences Curriculum Committee. The SBCCC also reviewed proposals from Health Sciences degree programs.

The committee approved the proposed BA in Biology with required minor, and approved significant updates to the Atmospheric and Oceanic Sciences, Environmental Studies, and Coastal Environmental Studies majors (with an approved change from Coastal Environmental Studies to a BS in Environmental Studies). We are waiting on approval from Albany to implement the changes.

The committee discussed the proposed deactivation of the German major and German Education track, and approved a revision to the German major to allow the major to remain active. The committee spent the majority of two meetings discussing the impact of the deactivation of the major. The committee discussed the suspension of the Dance minor and the suspended admission to undergraduate degree programs in Theatre Arts, Comparative Literature, and Cinema and Cultural Studies.

The committee approved three new minors: Health, Medicine and Society; Pharmacology; and Professional Writing.

The committee expressed significant concerns over the proposed minor in Narrative Filmmaking and the associated courses and requested additional information from the department before further consideration.

The committee discussed the recommendations of the SBC Implementation Group, including a possible new required online training in ethics/CER, and a new learning outcome, 'Foster Diversity and Inclusiveness.'

The majority of the committee meeting time was devoted to reviewing course proposals and syllabi for existing courses to determine applicability to the Stony Brook Curriculum learning outcomes, along with proposals for new courses. The committee also reviewed syllabuses for existing courses proposed as online courses, in many cases referring the faculty to the Faculty Center for a more in-depth review of the syllabus.
