# Report from Health Sciences Senior VP, Hal Paz

- Announced name change of the Department of Periodontology to the Department of Periodontology and Endodontics.
- We are continuing to move forward on the review of proposals to create a School of Public Health.
- Announced new dean of the School of Nursing.
- Dr. Todd Griffin has been appointed the Vice President for clinical services for Stony Brook Medicine.
- Will have two searches for Director of Cancer Center and Chief Communications and Marketing Officer.
- We're making continued progress on our new ambulatory care facility in Lake Grove.
- We're in a planning phase for a new outpatient surgery center.
- Excited about developing a long-term strategy for Stony Brook Medicine that includes our academic mission along with our clinical and community service mission, and this plan will be completed and in place by the end of the academic year.
- SBU Medicine is one of 25 institutions ranked as the nation's leading organizations dedicated to environmental sustainability and health care.
- We were named as leaders in LGBTIQQ plus healthcare equity for 2022.
- On Friday afternoon we had an unfortunate situation on the East campus which was a water leak that occurred from a fire marshal directed pressure test. It flooded our transformers, and a handful of classrooms and some lecture halls that are still offline. I want to thank everybody on the facilities team at the university for all the work they're doing to expedite repairs.
- Long Island is seeing the highest rates of COVID-19 in New York State.

Question – S. Finkelstein – There is quite a lot of reporting on healthcare capacity regarding high RSV, flu, and COVID rates. How is the hospital faring under these conditions?

Answer – At the present time, we are faring. We've used some expansion space and are dealing with the need for isolation space. I'll have to report back to you later because we're again heading into some unknown territory much like we were in 2021. As a result of vaccinations and native immunity we're hopeful that while it's likely infection rates will go up, the number of individuals who have to be hospitalized due to an infection will not climb at the same rate as we saw back then.

Question – R. Larson – What is the status of the National Cancer Institute application?

Answer – We have every intention of continuing to move forward to receive an NCI designation at Stony Brook University.
